Sub : Police Estt: - Grade Designation as SI on completion of 25 years of Qualifying service- orders issued - reg.

As per the reference 1st cited, it has been ordered to designate all ASIs / Grade ASIs who have completed 28 years of service including basic training period and working in the Local Police as SI (Grade) subject to certain conditions, in order to booster the sagging morale of Police Personnel who have not benefited by promotion for long period, which are detailed below. As per the order 2nd cited, it has been instructed to designate during the month in which they have attained the required period of qualifying service.

As per the order 3rd cited, the period for designation as SI (Gr) has been reduced to 27 years including training period. Further the period for designation as SI (Gr) has been reduced to 25 years including training period vide the reference cited fourth. The following conditions are to be satisfied for designating an ASI as " Grade SI ".

1. The regular and grade ASI must have completed a total service of 25 years including basic training period.
2. ASIs and ASIs (Gr.) must be drawing a pay in the scale of pay equal to or higher than that of SI.
- 3.The regular / grade ASI (GE) who has been designated as Sub Inspector of Police (Grade) will be promoted to the cadre of SI (GE) / ASI (GE) as and when his/her turn comes in the regular line of promotion, unless he/she is found ineligible.
4. SI of Police (Grade) will be the personnel rank of the persons so designated.
5. The persons so designated will be eligible to wear the uniform of the Sub Inspector of Police.
6. He/She will not be eligible for higher pay and allowances other than what he/she has been received, had not been designated as SI of Police (G).
7. The regular ASI designated with SI grade will be accommodated among the available sanctioned posts of the rank of Asst: Sub Inspector of Police (GE) till he/she attains promotion as SI as per his/her Cadre seniority. The Grade ASI designated with SI (G) will be accommodated in the sanctioned posts of SCPOs and promoted as ASI and SI in due course as per cadre seniority.
8. He/She can be entrusted with the duties and responsibilities of a regular SI of Police additionally in such manner and such an extent as the State Police Chief may deem fit.
9. He/She will not be eligible to claim seniority in the cadre of SI of Police (GE) on the basis of the designation.
10. These order will not alter the existing rules with regard to the disciplinary authority under KPDIP & A Rules and Manual of Disciplinary Proceedings.
