

UNLOCATED MURDER CASES.

1. **Valapattanam PS Cr.No. 1134/16** u/s 174 Crpc Altd Sec. 302 IPC on 09.6.16 D/O: Between 18.05.16 at 22.00 and 19.05.16 at 14.00 D/R: 21.05.16 at 20.20 P/O: Azhikkal Fishing harbour Complainant : Joy Rocha s/o Luyis age.45/16,Kalinka Rajapuram Accused : Not known Deceased : Biju s/o Anthoni. Brief of the case is that Between 18.05.16 at 22.00 hrs and 19.05.16 at 14.00 hrs dead body of one Biju found drawned at Azhikkal harbour according to the Postmortem report of Forensic surgeon Sec. altered to 302 IPC.

2. **Irikkur PS Cr.No. 372/16** u/s 397,302 IPC:D/o 30.04.16 between 09.00hrs and 16.15hrs D/r 30.04.16 at 22.30hrs. P/o- Sidhiq Nagar, Irikkur. Complainant : Ummar.M, S/o Moideen, Meradan House, Sidhiq Nagar, Irikkur. Deceased: Kunhamina W/o Moideen, 60/16, Meradan House, Sidhiq Nagar, Irikkur. Accused: Personnel residing in the quarters. Brief: The case in brief is that on 30.04.16 at 16.15hrs the complainant's mother Kunhamina was found seriously injured in the quarters near to her house, at Siddique Nagar ,after being stabbed with a knife and she died on the way to hospital. The accused is suspected to have committed the act for stealing the golden ornaments etc facts.

3. **Kuthuparamba Ps Cr. No. 130/2017** U/S 174 Cr.PC Altd Sec. 302 IPC. D/O 22.02.2017 between 03.00 Hrs. and 05.30Hrs. D/R 22.02.18 at 08.47 Hrs. P/O Mangattidam amsom, Kariyil .Complainant: Dineshan, S/O Vasu, Dipina Nivas, Kariyil, Nirmalagiri. Deceased: Rajan, 63/17, S/O RamanKunhiparambath House, Mangattidam amsom, Kariyil. Accused: Not known. Brief of the case is that one Rajan is seen died in a cashew plantation about 50 mtrs away from his house etc. facts. Postmortem reveals that the death is due to manual strangulation(Throtting). Accordingly Sec. 174 CrPC altd into 302 IPC.

4. **Karikkottakkari PS Cr.60/18** U/s 307 IPC altered Sec 302 IPC. D/O : 04.02.2018 at 05.45hrs D/R: 05.02.2018 at 11.34hrs P/o Ayyankunnu Amsom, Nattel. Complainant : Antony Kurian @ Aji, S/o Kurian, Age 52/18, Poonthott (H), Ayyankunnu Amsom, Nattel, Mundayamparamba. Accused: Unknown. Brief of the case is that on 04.02.2018 at 05.45 hrs at Ayyankunnu amsom, Nattel, the complainant's neighbour one Mary, W/o Joy, Periyapurath (H), Nattel was admitted to Pariyaram Medical College by serious burnings and succumbed to death on treatment. While the complainant reached the incident spot, the deceased told him that she was burned by someone behind her house. Initially this case was taken u/s 307 IPC and after that the section was altered into 302 IPC.
5. **Edakkad PS Cr.104/18** u/s 174 Cr.PCCC altered sec. 302 IPC on 18.03.18. D/O In between 19.30hrs. on 04.02.18 and 11.45hrs. on 05.02.18. Complainant : Balakrishnan, S/o Bappu 46/18, Koyilerian (H), Pallyath. Deceased : Sajith K S/o Palliyath Gopalan 36/18, Maniyur. Accused not known. The case in brief is that one Sajith was found dead his work place at Moonnuperiya. Connected this, a case registered as Cr.104/18 u/s 174 Cr.PC. Since the relatives of victim expressed their doubts in his death, DYSP Kannur took over the investigation. During the course of investigation section 174 Cr.PC altered into section 302 IPC etc. facts.
